***NOTE: If you decide to cancel the event, part of the deposit may be refunded according to the following Refund Schedule:

- Less than 30 days notice: **0%**
- 31 to 60 days notice: **50%**
- 61 or more days notice: **75%**

An agreed upon honorarium of \$600.00 (less the \$200 deposit) to be given following the conclusion of the event. Please make all checks payable to BIMT.

TRAVEL: The sponsoring organization will provide expenses for round-trip unrestricted coach airfare from Pittsburgh, PA, ground transportation, meals and tips. Expenses will be submitted under a separate invoice following the event for reimbursement.

HOTEL: Arrangements to be made by the sponsoring organization and direct-billed to their account. Please reserve a non-smoking room, with late check-out approved, and late arrival guaranteed. Dr. John will check in the evening prior to the event.

CANCELLATIONS: If this agreement is canceled by the sponsoring organization, the following schedule of percent of fee will be in effect from the time written notification is received at the office of BIMT.

30 days or less before engagement	100%
60 days or less before engagement	50%
90 days or less before engagement	25%
>90 days before engagement	0%

If the engagement is postponed, and notice is received in two weeks or more and rebooked within 30 days, 25% of the deposit will be applied to the new date. If notice is received in less than 2 weeks, the full deposit will be forfeited.

Dr. John has never canceled an engagement, been late, or failed to appear for an engagement. If this should occur, you will be sent a full refund for the amount of your check submitted with the Letter of Agreement. If educational materials were purchased, you will have the option to keep the materials or receive a refund.

BOOKS SALES & TOPOGRAPHY MAPS: *Devotional Treasures from the Holy Lands*

Dr. John's book reinforces the concepts he will be presenting to your group. The raised topography maps help illustrate the "playing board" of the Bible in a unique way.
